IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

AFTER INVESTING, WITHIN SIX MONTHS, OIL PRICES CRASHED 50% AND CLIENT'S ENERGY PORTFOLIO WENT DOWN AROUND 18% AND DIVERSIFIED PORTFOLIO WENT DOWN AROUND 2%, GIVEN CRISIS IN EUROPE WITH UKRAINE WAR ETC. CLIENT'S OVERALL J P MORGAN PORTFOLIO WAS DOWN 5% IN LAST SIX MONTHS. CLIENT WAS NOT HAPPY THAT WE WERE NOT ABLE TO PREDICT THE CRASH. REMINDED THE CLIENT THAT WE DO NOT TRY TO TIME THE MARKET FOR ENTRANCE INTO DIVERSIFIED STRATEGIES, WHICH ARE DESIGNED TO PERFORM OVER A FULL MARKET CYCLE. CLIENT'S OVERALL PORTFOLIO CAME BACK UP TO EVEN IN THE NEXT THREE MONTHS.
