What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement	This incident occurred over 30 years ago. I had completed my military service returning to Florida, where I was unfamiliar with the state's concealed carry laws. I mistakenly believed that my prior training and experience permitted me to carry concealed, without a state issued permit. As of 2025, permit less carry has been legal in the State of Florida for years. This was an error in judgement and I've



accepted responsibility for not taking the necessary steps to understand and comply with Florida's specific regulations on the matter as they were in 1994. Adjudication was withheld and the matter was formally resolved with a final disposition on November 9, 1994. I view this as a valuable learning experience that has shaped my commitment to compliance & accountability in my personal and professional life.
