IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: THE CLIENT ALLEGES THE FINANCIAL ADVISOR SOLD STOCK WITHIN HER ACCOUNT AND PAID HIM \$18,000 IN COMMISSION. WHEN SHE RECEIVED THE STATEMENTS IN THE MAIL, CONCERNED SHE CALLED THE FINANCIAL ADVISOR. THE CLIENT STATES THE FINANCIAL ADVISOR RESPONDED THAT HE WAS BALANCING THE ACCOUNT. WHEN ASKED ABOUT THE TAX LIABILITY, THE CLIENT ALLEGES THE FINANCIAL ADVISOR SAID THERE WOULDN'T BE ANY TAX LIABILITY. SHE ASKED THE FINANCIAL ADVISOR NOT TO PLACE ANY MORE TRADES WITHOUT HER PERMISSION, AND REMINDED HIM THAT SHE MOVED HER ACCOUNT TO THE FIRM WITH THE INTENT OF LEAVING IT AS IS BECAUSE SHE WAS PAYING A HIGH MONTHLY FEE FOR A MANAGED ACCOUNT. SHE INDICATES SHE WAS SHOCKED TO HAVE RECEIVED A \$62,000 TOTAL TAX DUE NOTIFICATION. SHE IS REQUESTING THE TAXES BE PAID AND THE COMMISSIONS RETURNED.
