IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: Firm stated that it was not in the best interest of the client to do a trade that was close to a breakpoint. The breakpoint was 100k and the trade was 90k. It was disclosed to the client 2 times and reviewed along with a manager, and the client was in agreement with the trade, and fully understood.

Product Type: Mutual Fund

Broker Statement The client was trading out an annuity and part of the funds were going to a mutual fund and the other to a managed account. The client settled on a certain amount they wanted in the managed account and the rest went to mutual funds. When the funds transferred over from the annuity the amount going to the mutual fund was 10k short of a break point in the mutual funds. This was fully discussed with the client and agreed upon, and discussed again with a supervisor / manager at the firms request with no rebuttal from the client. Left the phone call with the manager



stating that everything seems to be in good order and that I would continue as normal and 2 days later was informed that with the change to LPL that they did not want to sponsor my licenses and that I was terminated immediately.
