What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

This small claims suit was a result of a home sale to children of a friend the end of April 2022. He sold the home with a 3-month rent back agreement allowing him to remain in the home until his new home, under construction, was completed. In exchange, he would pay their mortgage for 2 months (principal and interest for June and July, since there was no May mortgage payment). The rent back agreement was a verbal agreement. The purchasers sued Robert for mortgage and interest due for May, which Robert has since found evidence to support that no payment was due. Robert immediately filed an appeal with a motion to vacate and his attorneys believe the entire suit will be thrown out.
