At the time of account opening, all proper written and verbal disclosures were given to engage in a conservative, well diversified, and professionally managed portfolio on a fee only (Non commission) basis. When market volatility increased, due to the COVID-19 pandemic, I received notice that the client wanted to initiate a liquidation of the portfolio after only several weeks despite my best efforts to discuss / reaffirm his long term time horizon and the use of these funds for retirement. In doing so, on an unsolicited basis, the client locked in his own losses.
