IAPD Information About Representatives

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: On September 6, 2022, the Securities Division entered into a Consent Order with Pinnacle Opportunity Team, LLC ("Pinnacle"), a Washington LLC, and its managing member, Ryan A. Purdie ("Purdie") (collectively, "Respondents"). Purdie is a California-registered investment adviser representative. The Securities Division alleged that during 2019, Purdie offered and sold membership interests in Pinnacle totaling at least \$70,000 to at least four New York investors. Pinnacle has never been registered to sell its securities in Washington. The Securities Division alleged that the Respondents misrepresented the likely return on the investment and failed to disclose material information regarding the investment. The Securities Division alleged that Respondents offered and sold unregistered securities and violated the anti-fraud provision of the Securities Act of Washington. Without admitting or denying the Securities Division's allegations, the Respondents agreed to cease and desist from violations of RCW 21.20.140, the securities registration section of the Securities Act and RCW 21.20.010, the anti-fraud section. The Securities Division imposed a fine of \$2,500. The Respondents each



waived their right to a hearing and judicial review of the matter.
