What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

The Client signed and agreed to all investment platforms, and during the ten months that they were a client, they were made aware of all investments. The client received trade confirmations, online access, monthly statements, supplemental trade summaries, and account performance reviews (including numerous in-office reviews and phone conferences). Against the recommendation of the formally documented and agreed-upon financial plan, The Client decided to exit the market at an inopportune time only to find that the markets had recovered soon after.

It should be noted that all transactions were conducted on an annual fee basis, and not a per transaction basis.
