### What is included in a IAPD report?

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

THE CLAIMANT GENERALLY ALLEGES THAT THE RESPONDENT MADE MATERIAL FALSE AND FRAUDULENT REPRESENTATIONS AND VIOLATED VARIOUS STATE SECURITIES LAWS AND MISMANAGED THE CLAIMANTS' MANAGED ACCOUNTS. RESPONDENT DENIES ALL ALLEGATIONS MADE BY CLAIMANT. ALLEGED COMPENSATORY DAMAGE AMOUNT WAS \$2,959,805. THE MATTER WAS SETTLED ON FEBRUARY 3, 2023 IN THE AMOUNT OF \$270,000 TO AVOID THE FURTHER COSTS OF LITIGATION.
