Broker Statement

I deny the allegations. Client gave instructions to place a Rule 144 trade. I called the Rule 144 desk before I entered the order and was told I should indicate as a 144 transaction in the free form area of the order ticket and work with the trader. It was my understanding that by adding the 144 notations on the order ticket, that the order would route to the trader. However, it was not and trade was processed as a market order. The client never asked that the order be worked overtime. This was a misunderstanding as I followed the instructions given to me by the 144 desk and was waiting for the trader to call me to discuss the order. I never received the call. Client's complaint was settled for good client relations reasons. Client's order was adjusted to reflect price at time of order and was settled to client's satisfaction. This was an operations and communications error.
