IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Firm Statement THE FOLLOWING STATEMENT BY THE REGISTERED REPRESENTATIVE IS BEING ADDED AT HIS REQUEST AFTER TERMINATION OF HIS AFFILIATION WITH 1ST GLOBAL.

IN FEBRUARY 2008, A CLIENT OF OURS WAS CONSIDERING SELLING THEIR BUSINESSES TO A THIRD PARTY THEY HAD IDENTIFIED AND WE DISCUSSED THE POSSIBILITY OF MODIFYING OUR COMPENSATION ARRANGEMENT TO INCLUDE A 1% SUCCESS FEE PAYABLE AT CLOSING, NET OF AN HOURLY CONSULTING FEE THEY WERE PAYING ME, TO ASSIST THEM WITH THE TRANSACTION. I IMMEDIATELY CONTACTED THE PRESIDENT AND CEO OF 1ST GLOBAL CAPITAL TO SEE IF THEY MIGHT CONSIDER REACTIVATING THEIR SUBSIDIARY THAT I UNDERSTOOD WAS PREVIOUSLY REGISTERED WITH FINRA FOR M&A SERVICES SO THAT I COULD EARN A SUCCESS FEE. HE SAID THEY DID NOT WISH TO DO SO, AND THAT I WOULD HAVE TO MAKE A DECISION ABOUT STAYING WITH 1ST GLOBAL OR NOT IF I WANTED TO OFFER THESE SERVICES AND BE ABLE TO EARN A SUCCESS FEE. BEFORE I MADE A FINAL DECISION, 1ST GLOBAL TERMINATED MY RELATIONSHIP WITH THEM. I REPRESENT THAT WHILE I WAS AFFILIATED WITH 1ST GLOBAL, I WAS NEVER PARTY TO A



CONTRACT FOR A SUCCESS FEE.
