What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Employing firm when activities occurred which led to the complaint: Ausdal Financial Partners

Allegations: Clients alleges that Mr. Mincy sold out his account without permission on June 18, 2018. The client is also asking that two securities, GRCO and IDCC, be purchased back in the account. The client's account was restricted and the only allowed action was full transfer out, or liquidation and transfer of proceeds at the time of the sale and Mr. Mincy received verbal instruction from the client to liquidate the account and send paperwork to transfer funds. The account was later frozen by the clearing firm. The account was restricted and eventually frozen based on instruction by the FBI in relation to a guilty plea by the client for federal criminal charges. The client is currently in prison.
