What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

SECURITY CUSTOMERS WERE INVOLVED. WE ARE CURRENTLY IN THE PROCESS OF ARBITRATION TO DISPUTE THE REPOSE ON PNC'S U5. ARBITRATION DATES HAVE BEEN TENTATIVELY SET FOR SEPTEMBER 12-13. A CUSTOMER COMPLAINED TO THE BANK THAT HER NAME AND PHONE NUMBER HAD BEEN GIVEN BY ME TO AN INSURANCE AGENT WITHOUT HER PERMISSION, AND THAT THE AGENT HAD LEFT A MESSAGE ON HER VOICE MAIL TO INQUIRE IF SHE WAS INTERESTED IN PURCHASING HOMEOWNER'S INSURANCE (A PRODUCT NOT PROVIDED BY THE BANK). PREVIOUSLY, WHILE HELPING THIS BANK CUSTOMER OBTAIN A HOME EQUITY LOAN, I ALSO RECOMMENDED SHE REVIEW HER HOMEOWNERS INSURANCE TO MAKE SURE SHE WOULD BE ADEQUATELY INSURED AND AT THE BEST RATE. I THEN RECOMMENDED THREE HOMEOWNERS' INSURANCE COMPANIES THAT THE CUSTOMER COULD CONTACT, AND ALSO TOLD THE CUSTOMER THAT MY HUSBAND WAS AN INSURANCE AGENT FOR LIBERTY MUTUAL, AND SHE COULD CONTACT HIM IF SHE WISHED. THE WOMAN ASKED TO HAVE HIM CALL HER, AND GAVE ME HER CONTACT INFORMATION TO FORWARD IT. THIS WAS DONE WITH THE CONSENT OF THE CUSTOMER. THIS REFERRAL DID NOT APPEAR TO VIOLATE ANY BANK POLICY AS MY HUSBAND HAD BEEN ASKED TO PARTICIPATE WITH THE BANK'S MORTGAGE LOAN OFFICERS AS A RESOURCE. MY UNDERSTANDING OF THE POLICY WAS I COULD REFER TO A THIRD PARTY AS LONG AS I PROVIDED 3 OPTIONS. I DO NOT KNOW WHY THE INVESTIGATOR CHOSE TO BELIEVE THE CUSTOMER RATHER THAN MYSELF- AN EMPLOYEE OF 3 YEARS WITH NO PREVIOUS COMPLAINTS OR UNSATISFACTORY PERFORMANCE REVIEWS.
