**Broker Statement**

I deny the allegations and believe them to be false. I began working with the client after his former advisor left the firm. It should be noted that I did not sell any of the annuities held in his accounts nor was the annuity in question purchased at UBS. I had numerous meeting with him both virtual and in person while developing a financial plan for him. Over the two years I was associated with the accounts, the client received multiple reviews, updates, and detailed recap emails outlining his financial plan, investments, and annuities. In March 2025, during a scheduled account review, we reviewed the annuities

And I provided him with a detailed email summarizing our discussion. In regard to his claim regarding not knowing about the surrender penalty, this allegation is totally false. The surrender fee was clearly explained, even though I did not sell this annuity to the client, I made sure that he understood the features of the annuity. The charge (pro rata fee for his 5% Guaranteed Minimum Income Benefit would be deducted from his contract value upon surrender) was reflected in the annuity contract, on his 3/31/25 quarterly statement, and in screenshots the client provided to me prior to the completion of the surrender of the annuity. Based on these facts, I strongly disagree with the allegations as the client was fully informed about his annuities and had signed off on all material before making his surrender decision.
