What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

This complaint is a continuation of a complaint received against the firm in January, 2015 and October 2017 respectively. The customer complained that he has been unable to get back mandatory withholding forward to the IRS by our clearing firm in 2013. Throughout, the firm explained to the customer the reason the clearing firm withheld the mandatory withholding and forward the funds to the IRS. The firm provided all relevant documentation obtained from the clearing firm and even tried to assist in making filings with the IRS. There has been no activity in the customer's account since 2013, years before receipt of the initial complaint and no activity subsequent to 2013. In his most recent complaint sent to our clearing firm and FINRA, Customer adds an allegation, for the first time since 2013, of unauthorized trading without specificity and totally without basis. Then on September 7, 2020, customer wrote an email of apology to the firm. Unfortunately, FINRA rules require us to blemish the Mr. Martinez's pristine history by reporting this absurd and unfounded allegation of unauthorized trading on Mr. Martinez's Form U-5 more than 7 years after the last transaction in the customer's account.
