**Regulator Statement**

On 7/24/2019, the Office of Financial Regulation entered a Final Order adopting the Stipulation and Consent Agreement in the matter of Theodore J. Cardasis. Mr. Cardasis accepts, consents and agrees, prior to a hearing and without an adjudication of any issue of law or fact, to the findings of the Office. The Office found that Theodore J. Cardasis engaged in investment advisory business from a location within this state without the benefit of lawful registration in the state of Florida, pursuant to section 517.12(4), F. S. Theodore J. Cardasis agreed to cease and desist from all present and future violations of Chapter 517, F. S. and the administrative rules thereunder; and to pay an administrative fine in the amount of \$ 12,500. The Office agreed to approve Theodore J. Cardasis' application as an associated person (RA) with Mariner Wealth Advisors effective 7/24/2019.

**Broker Statement**

As a result of an administrative error by Mariner, LLC d/b/a Mariner Wealth Advisors, CRD No. 140195 ("MWA"), Theodore Cardasis (Mr. Cardasis) was not registered with the Florida Office of Financial Regulation ("Office") as an investment adviser associated person of MWA upon the commencement of his employment with MWA. Mr. Cardasis relied on MWA to complete and maintain the proper registrations relating to his employment duties. Although MWA did register Mr. Cardasis as an investment adviser representative (IAR) in the State of New Jersey and completed the necessary registrations for his broker-dealer and insurance licenses in the State of Florida, MWA inadvertently failed to process the necessary paperwork for Mr. Cardasis' IAR registration in the State of Florida. Mr. Cardasis had previously been registered as an IAR in the State of Florida prior to the commencement of his employment with MWA. On 07/24/2019, the Office issued a final order finding that Mr. Cardasis engaged in investment advisory business from offices within Florida without the benefit of lawful registration in Florida, pursuant to section 517.12(4) of the Florida Statutes. Without admitting or denying the findings, Mr. Cardasis accepted the findings and agreed to cease and desist from all present and future violations of Chapter 517, Florida Statutes and the rules thereunder. The Office agreed to approve Mr. Cardasis' application as an associated person with MWA, effective 07/24/2019.
