## IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

FA RECOMMENDED CONSOLIDATING CURRENT HOLDINGS AND LIQUIDATING AN ING ANNUITY (WHICH WAS OUT OF THE PENALTY PHASE) AS WELL AS OTHER ASSETS AND INVESTING IN MUTUAL FUNDS AS HE BELIEVED THIS WOULD GIVE HER THE OPPORTUNITY FOR GROWTH AND INCOME AND SYSTEMATIC WITHDRAWALS WOULD BE ESTABLISHED TO PAY NURSING HOME COSTS. THE FUNDS APPEARED TO BE WITHIN THE SCOPE OF THE INVESTMENT OBJECTIVES OF THE CLIENT OF GROWTH, GROWTH AND INCOME. THE TRADES WERE AUTHORIZED BY THE ATTORNEY-IN-FACT. THE ACCOUNT WAS FROZEN AT THE TIME OF CLIENT'S DEATH UNTIL ESTATE DOCUMENTATION WAS RECEIVED; HOWEVER, THE FUNDS REMAINED SUBJECT TO MARKET FLUCTUATION. INSTRUCTIONS WERE RECEIVED ON 10/15/08 FROM THE APPOINTED EXECUTOR TO LIQUIDATE THE POSITIONS. THE PROCEEDS WERE HELD IN MONEY MARKET AWAITING DISTRIBUTION INSTRUCTIONS. IT IS OUR OPINION BOTH ACCOUNTS WERE HANDLED APPROPRIATELY. CLAIM DENIED.
