IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: On or about September 22, 2014 [REDACTED] & [REDACTED] met with Mr. Hoag to change broker from Mid Atlantic to Hazard & Siegel. On or about October 23rd clients visited the office to complain about their monthly contribution from their joint checking account which did not occur due to incorrect paperwork. During the October visit the clients became agitated calling staff incompetent and claiming that initials on paperwork were forged. Clients emailed the firm on November 18, 2014 however has not, as of today, responded to our calls and our letter to inform them that there were conflicting reports on what actually occurred during the October visit to the office. A letter to the clients dated August 20, 2015 stated that the firms investigation was being closed since we hadn't heard from them.
