IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement	On January 14, 2025, the Californial Department of Insurance issued an Order granting the Representative's Petition for Reconsideration and vacating the Order



of Revocation.

In February 2025, the Representative entered into a Stipulation and Waiver with the California Department of Insurance in which the Representative agreed that the allegations were true and were grounds for revocation of his California license. In doing so, the Representative asked that the California DOI issue him a restricted insurance license requiring that he "obey the laws and regulations of the State of California, the United States of America, every state and foreign government and any regulatory authority having jurisdiction over" the Representative. On February 12, 2025, the California DOI issued an Order Adopting the Stipulation Waiver.
