IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Broker Statement**

I VOLUNTARILY RESIGNED FROM CHARLES SCHWAB ON GOOD TERMS, EFFECTIVE NOVEMBER 8, 2023. IN THE FIRST HALF OF 2023, WE DISCOVERED THAT A SAN FIRM (ALSO KNOWN AS SCHWAB ADVISOR NETWORK, A THIRD-PARTY REGISTERED INVESTMENT ADVISOR VETTED & APPROVED BY SCHWAB) HAD CREATED DUPLICATE REGISTRATION SEPARATELY MANAGED ACCOUNTS, DIVIDING FIXED INCOME FROM EQUITIES, A COMMON INDUSTRY PRACTICE. REGRETTABLY, THESE



ACCOUNTS WERE INCORRECTLY DESIGNATED AS INSTITUTIONAL CLIENT ACCOUNTS, RESULTING IN IMPLICATIONS FOR INCENTIVES AND NECESSITATING CORRECTIVE ACTION TO ENSURE COMPLIANCE WITH SCHWAB. UPON IDENTIFICATION OF THE ISSUE, OUR SCHWAB OPERATIONS TEAM INFORMED THE SAN FIRM OF THEIR INABILITY TO RECTIFY THESE ACCOUNTS INDEPENDENTLY. RECOGNIZING THE URGENCY, I ASSUMED RESPONSIBILITY FOR MANAGING THE OPERATIONS AND INITIATED PROACTIVE COLLABORATION WITH OUR INTERNAL SCHWAB PARTNERS/OPERATIONS AND THE SAN FIRM TO EXPEDITE THE RESOLUTION PROCESS. I GATHERED ALL PERTINENT INFORMATION AND METICULOUSLY VERIFIED THE SUITABILITY CRITERIA FOR RECLASSIFYING THESE ACCOUNTS ACCURATELY. MY APPROACH INVOLVED COMPREHENSIVE DOCUMENTATION OF ALL COMMUNICATION, INCLUDING CALLS, MESSAGES, AND EMAILS EXCHANGED WITH THE SAN FIRM, CLIENTS, AND OUR BACK OFFICE. HOWEVER, AN ALLEGATION AROSE CONCERNING A SINGLE INSTANCE WHERE I WAS UNABLE TO REACH A CLIENT AND LEFT A MESSAGE, LEADING TO AN UNINTENDED OVERSIGHT. WHILE I BELIEVED I HAD TAKEN APPROPRIATE PRECAUTIONS BY DILIGENTLY DOCUMENTING ALL INTERACTIONS WITH THE SAN FIRM AND OUR INTERNAL SCHWAB PARTNERS/OPERATIONS, IT BECAME EVIDENT THAT THESE NOTES ALONE WERE INSUFFICIENT IN ADDRESSING THE CONCERN. FURTHERMORE, IT'S IMPORTANT TO HIGHLIGHT THAT NO CLIENT WAS NEGATIVELY AFFECTED, AND THERE WERE NO CLIENT COMPLAINTS. ALSO, THIS MAINLY OPERATIONAL MATTER WAS ADDRESSED, RECTIFIED, AND RESOLVED PRIOR TO MY VOLUNTARY RESIGNATION. MOVING FORWARD, I REMAIN STEADFAST IN MY COMMITMENT TO UPHOLDING THE HIGHEST STANDARDS OF PROFESSIONALISM AND COMPLIANCE IN MY ROLE. TO FORTIFY THIS DEDICATION, I AM ACTIVELY PURSUING ADDITIONAL COURSES AND CERTIFICATIONS TO UPHOLD THE FIDUCIARY STANDARD.
