THE CASE WAS FILED ON THE JEFFERSON CIRCUIT COURT FOURTEENTH DIVISION, LOUISVILLE, KENTUCKY. THE SETTLEMENT OF CASE #84-CI-05422, [CUSTOMER] VS. PAUL CORLEY AND MARION BASS SECURITIES CORP. MR.
