Regulator Statement

On 6/6/2020, the Office of Financial Regulation entered a Final Order adopting the Stipulation and Consent Agreement in the matter of Marianne Resue Hutchins. Ms. Hutchins admits to the finding of the Office. The Office found that Marianne Resue Hutchins engaged in investment advisory business from offices within this state without the benefit of lawful registration in the state of Florida, pursuant to section 517.12(4), F. S. Marianne Resue Hutchins agreed to cease and desist from all present and future violations of Chapter 517, F. S. and the administrative rules thereunder; and to pay an administrative fine in the amount of \$ 7,500. The Office agreed to approve Marianne Resue Hutchins' application as an associated person (RA) with E*Trade Capital Management, LLC effective 6/6/2020.

Broker Statement

Ms. Hutchins is an employee of ETCM's affiliate, E*TRADE Securities LLC ('ETS'), and worked from an E*TRADE branch office located in Georgia until March 24, 2019. Ms. Hutchins holds licenses as a broker-dealer representative and an investment adviser representative ("IAR"). She provided E*TRADE with written notice of her relocation to Florida as E*TRADE handles the paperwork for its licensed broker-dealer and IAR representatives in their resident state.

Ms. Hutchins's U4 license was appropriately and promptly updated to reflect her relocation. However, due to an oversight within E*TRADE, the application for an IAR registration as an associated person of ETCM in Florida was not submitted at the same time.

E*TRADE discovered the issue as part of its review of licensing and registration for its registered representatives in December 2019 and the Registration Department promptly submitted a request for IAR registration for Ms. Hutchins to the Division of Securities.
