IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

PNC Investments and I entered into a Consent Order with the state of North Carolina related to an inadvertent gap in my registration as an investment adviser representative (IAR) in the state. I had been appointed as a non-resident agent in North Carolina dating back to April 2015. While it is PNC Investments' practice to file IAR applications on behalf of its financial advisors, due to an administrative oversight, the firm did not immediately file my IAR application upon being promptly notified of my move to North Carolina in December 2021. As a result, my IAR registration was maintained in my former resident jurisdictions of Ohio and Indiana, instead of being amended with my resident status in North Carolina. After PNCI discovered the error in October 2023, the firm proceeded to file my IAR application in North Carolina, which prompted the issuance of the order, and a fine to the firm.
