IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. Reporting Source: Individual

Employing firm when activities occurred which led to the complaint: Sorrento Pacific Financial, LLC

Allegations: Client sent e-mail complaint to SPF related to sales charges assessed as part of sale of two mutual fund positions which was related to a prior verbal complaint that was settled by SPF for \$4,476. SPF reviewed the matter and determined that the representative did not properly re-confirm the transaction instructions before placing the initial purchase orders. Client later submitted a written complaint related to sales charges incurred as part of sale of the same mutual funds. SPF agreed to a separate settlement for sales charges in the amount of \$5,947 for a total aggregate settlement with client in the amount of \$10,424.

Product Type: Mutual Fund

Alleged Damages: \$10,424.00

Alleged Damages Amount Explanation (if amount not exact): Client had previously submitted verbal complaint concerning confirmation of trade instructions resulting in a settlement of \$4,476 for market losses. Client later submitted written complaint via e-mail for sales charges assessed on same transactions in the amount of \$5,947 which was also settled by firm. Aggregate total of settlements is \$10,424.
