THE CLIENT CLAIMS DURING THEIR DISCUSSION OF TRANSEFERRING THE SHARES TO AMERIPRISE THE WORDS SELL OR SALE DID NOT COME UP, HOWEVER, THE FA DID MENTION THEIR WOULD BE \$2943.08 IN COMMISSION. THE CLIENT CLAIMS SHE THOUGHT THIS WAS A TRANSFER FEE FROM ONE COMPANY TO ANOTHER. THE CLIENT STATED SHE SIGNED THE TRANSFER FORM AT AMERIPRISE TO HAVE THE SHARES TRANSFERRED IN KIND, HOWEVER, 6308 SHARES WERE LIQUIDATED. THE CLIENT IS REQUESTING THE REINSTATEMENT OF ALL SHARES PLUS DIVIDENDS. FILING REQUIRED.

THE CLIENT HAD A WORKING RELATIONSHIP WITH AMERIPRISE AND WAS GROWING CONCERNED AT THE LENGTH OF TIME THEY WERE TAKING TO GET TRANSFER PAPERWORK TO EDWARD JONES AND HOW THE DELAY WAS AFFECTING THE VALUE OF THE SHARES. THE FA DISCUSSED WITH THE CLIENT THE DETAILS IF SHE DECIDED TO SELL THE SHARES THEN TRANSFER, TO INCLUDE COMMISSION. THEY TALKED ABOUT THE PROCEEDS BEING HELD IN CASH AND THAT WAS NOT A PROBLEM FOR THE CLIENT. ON 6/24/10 AFTER THE CLOSE OF THE MARKET LIQUIDATING THE SHARES WAS AGAIN DISCUSSED AND THE CLIENT WAS TOLD IF SHE WAS CONCERNED ABOUT THE MARKET, THE TRADE COULD BE PLACED FILLING AT THE OPEN ON 6/25/10. THE CLIENT EXPRESSED CONCERN AS TO WHICH FA WOULD RECEIVE THE COMMISSION DEPENDING ON THROUGH WHICH FIRM THE SHARES WERE LIQUIDATED. THE CLIENT DECIDED IT WAS BEST TO LIQUIDATE AT THAT TIME AND THE TRADE WAS PLACED AND THE ORDER FILLED ON 6/25/10. THE TRANSFER INSTRUCTIONS WERE RECEIVED FROM AMERIPRISE DATED AND SIGNED ON 6/28/10, WHICH WAS AFTER THE CLIENT INSTRUCTED THE FA TO PLACE THE SELL ORDER. SEVERAL DISCUSSIONS WERE HAD REGARDING THE LIQUIDATION OF THE STOCK AND THE COSTS OF LIQUIDATION WERE DISCUSSED. ADDITIONALLY, THE FACT THAT THE CLIENT WAS CONCERNED WITH WHICH ADVISOR WOULD RECEIVE THE COMMISSION UPON LIQUIDATION INDICATES UNDERSTANDING THAT THE SHARES WERE GOING TO BE SOLD. THE PENDING SALE WAS REFLECTED ON THE 6/10 STATEMENT AND THE COMPLETED LIQUIDATION REFLECTED ON THE 7/10 STATEMENT AS WELL AS THE TRADE CONFIRM. IT DOES NOT APPEAR AS THOUGH THE CLIENT BROUGHT THIS TO THE FIRM'S ATTENTION AT THAT TIME. CLAIM WAS DENIED.
