IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

THIS HAPPENED ON MULTIPLE OCCASSIONS, AND EACH TIME THE CLIENT REFUSED TO SELL THE ANNUITY, STATING IT WAS PERFORMING WELL AND WAS A GOOD INVESTMENT. THE FA EXPLAINED TO THE CLIENT, THE INVESTMENT IS EITHER SUITABLE OR NOT SUITABLE. FURTHER, OUR INVESTIGATION REVEALED THE INVESTMENT WAS PURCHASED FOR THE BENEFITS IT COULD PROVIDE, SUCH AS THE ABILITY TO TURN ON AN INCOME STREAM, TAX DEFERRAL, AND THE DEATH BENEFIT. THIS IS SUBSTANTIATED BY THE PAPERWORK AND DELIVERY RECEIPT SIGNED BY THE ANNUITY OWNER. WE BELIEVE HAD THE CLIENT FELT THE ANNUITY WAS NOT SUITABLE, THEY WOULD HAVE BROUGHT IT TO THE FA'S ATTENTION DURING THE FREE LOOK PERIOD, OR CERTAINLY SOLD IT WHEN IT WAS UP IN VALUE. BASED ON OUR REVIEW, THE REQUEST TO REFUND THE \$7,000.00 WAS DENIED. THE CLIENT'S HUSBAND HAS EXPRESSED DISSATISFACTION ON SEVERAL OCCASSIONS TO THE FA AND EXPRESSED HIS DISSATISFACTION TO ME ON THE PHONE WHEN I WAS SPEAKING WITH THE ANNUITY OWNER. WE WANT THE CLIENT TO RECEIVE THE SERVICE THEY FEEL THEY DESERVE. AS A RESULT WE ARE OFFERING TO REIMBURSE THE CLIENT THE \$95.00 TERMINATION FEE TO TRANSFER THE ACCOUNT TO ANOTHER FIRM WITHIN 30 DAYS. ACCOUNT TRANSFERRED, \$95.00 FEE REIMBURSED.
