**Allegations:** In a written complaint, dated June 21, 2019, addressed to Bankers Life and Casualty Company (BLC), an insurance company affiliate of the Firm, [REDACTED] alleged that Nicholle Zoltaszek, a Registered Representative of the Firm, misled her into purchasing two Equity Indexed Annuities (EIAs) issued by BLC in April and December of 2018. [REDACTED] alleged that the fees, expenses, surrender charges of the EIAs were never explained to her. [REDACTED] requested that BLC cancel her annuities without any surrender fees. BLC determined that the purchase of the EIAs were suitable for the client and she was aware of surrender charges and other features of the EIAs. While the EIAs sold to [REDACTED] were not securities and were issued by BLC, the Firm is reporting this complaint because the source of funding for the BLC annuities came from the sale of securities recommended by a Registered Representative of the Firm.
