IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement Complainant alleged inappropriate use of discretion in the client's managed account. This complaint arose in the context of a former financial adviser leaving



the firm, and the firm continuing with the management in place with respect to an already established managed account. Rocky was assigned as the new financial adviser, and the firm provided correspondence to the client advising her that the account could be moved if that was her desire, or that she could terminate management in light of the fact that her financial adviser had been terminated from the firm. That correspondence advised that the account would be traded according to a suitable discretionary account model if we did not hear back from her. Hearing nothing back from the client, the IA made allocations as required by the account management agreement and consistent with the fiduciary duty of the IA. The account documentation clearly identified that the firm had discretion to trade the account, and we did so after attempts to contact the client were made.
