IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	I met with the client on many occasions including four in person appointments and



had seven phone conversations to discuss rollover process, investment recommendation, and fees associated with the investment. Client was informed multiple times of investment risks, costs, fees, and charges. Client confirmed with his own accountant that sales charges and expenses were reasonable. Client decided to move forward and signed a mutual fund fee disclosure form. Client met with me one additional time after purchasing mutual funds and did not express any displeasure with sales charges but was concerned about market fluctuation. Client remained invested according to financial goals. A few months later, client liquidated the majority of his holdings, against my recommendation over three years ago, but maintained the client-advisor relationship without any complaints or issues. All meetings and phone conversations were documented.
