IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

I was not named as a respondent to this arbitration. The client filed an arbitration against UBS in connection with the selling of the options overlay strategy. This claim is required to be on my U4 based on FINRA's rule which requires the Firm to file on all Registered Representatives who could be associated with the alleged sales practice allegations even if that specific broker is not named specifically in the Arbitration Statement of Claim. After the arbitration hearing concluded, the Arbitration Panel found in the favor of UBS and awarded the Claimant \$0 for his efforts. I will be working to have this factually inaccurate filing expunged from my professional record based on the Panel's decision.
