IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: Without admitting or denying the findings, Hayut consented to the sanctions and to the entry of findings that she accepted two monetary gifts totaling \$50,815 from a senior customer, one of her long-time clients, in violation of her member firm's policies. The findings stated that both checks were issued from one of the customer's accounts at the firm and were made payable to the synagogue to which Hayut belonged. The funds from the checks were applied to Hayut's account and were used to pay for various expenses. Hayut's acceptance of these gifts violated the firm's gift policies. Hayut was aware of the firm's gift policies and did not disclose her acceptance of the checks to it. In addition, after accepting the first check, Hayut incorrectly answered "no" to a question on her annual compliance questionnaire regarding whether she had received a gift from a customer valued at over \$100 within the last 12 months.
