IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	The investment at issue was appropriate for the customer, consistent with her investment objectives, risk tolerance, time horizon, and liquidity needs at the time she made the investment, and represented a portion of the customer's assets that were within LPL's guidelines for alternative investments. I explained the risks and attributes of the investment to the customer. The customer acknowledged in writing that she understood these risks and attributes, and that she received all material disclosures. I deny any wrongdoing in recommending this investment or the handling of the customer's accounts in general. LPL, to avoid the expense of prolonged litigation, made the business decision to resolve the case by agreeing to settle for a very small fraction of what the customer sought. I was not a party to the settlement agreement and was not asked to contribute to the settlement payment.
