**Broker Statement**

The firm's review showed that the client had positive returns in the account which were consistent with the benchmark index for the client's risk level, and there was no misappropriation by the advisor. The firm determined that its supervisory team did not perform a sufficient review of the client's request to liquidate an annuity in 2017 to fund the account, and has reimbursed the client for the surrender charges assessed on the liquidation in the amount of \$5,034.96.
