### **What is included in a IAPD report?**

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

**Broker Statement** Beginning on November 11th, 2023. An internal review was performed regarding the altering of client documents. The allegation was made that the date of a client signature was altered using whiteout. Fifth Third never showed me physical evidence of client names, accounts, documents, or number of instances that my use of whiteout may have occurred. As a result, my knowledge of the specific violation is limited. I can attest that the use of the white out was used exclusively for correction of customer information on applications.



On December 6th, 2023, I was terminated from Fifth Third upon the conclusion of the aforementioned review. No further documentation of any transgression was provided.
