**Broker Statement**

Update: Effective 9/21/2020, Client withdrew his complaint. This matter is now closed.

Mr. Gibbs vehemently denies the client's allegations. Mr. Gibbs executed the client engagement exactly as instructed by the client. The client is a sophisticated investor with a net worth in excess of \$20,000,000 who selected the strategies he wished to be invested in. The client signed off on every strategy implemented and had an opportunity to provide restrictions/comments as to the strategy as part of the client agreement had he wished to do so.

The client only made this claim after the market had experienced a sudden downturn because of the COVID pandemic. The client's realized losses of approx. -9% of his accounts' were the result of his own decision (which was against the advice of Mr. Gibbs) to sell investment strategy assets on 3/16/2020 just 5 trading days before the bottom of the market downturn on 3/23/2020.

The Kocen Financial Group, Inc. believes there is no merit to the allegations.
