What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement ON MARCH 17TH, 2012, I WAS ON A ROOFTOP IN BOSTON, MA AND ACCIDENTALLY FELL THROUGH A GLASS SKYLIGHT INTO THE BUILDING'S STAIRWELL. AS I WAS ATTEMPTING TO GET OUT OF THE BUILDING, POLICE ARRIVED AND ARRESTED ME ON THE STATED CHARGES. BECAUSE THE EVENT OCCURRED AFTER DARK, THE UNARMED BREAKING AND ENTERING CHARGE WAS DEFAULTED TO A FELONY. BECAUSE THE BROKEN SKYLIGHT WAS VALUED AT OVER \$250, THE DESTRUCTION OR INJURY OF PERSONAL PROPERTY WAS DEFAULTED TO A FELONY. DURING MY PRE-TRIAL HEARING, THE JUDGE FOUND THAT THERE WAS NO INTENT TO HAVE COMMITTED EITHER ACT, AS THE EVENT WAS AN ACCIDENT, AND DISMISSED BOTH CHARGES. THERE HAVE BEEN NO ADDITIONAL OR RESIDUAL ACTIONS RESULTING FROM EITHER CHARGE.
