What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

WE WERE STAYING AT THE HYATT REGENCY KAUAI, AND HAD BEEN THERE FOR SEVERAL DAYS. ON THE EVENING OF THE INCIDENT I TOOK TWO BEERS OUT OF AN OPEN POOL BAR HUT. SINCE THE HOTEL HAD SURVEILLANCE, THEIR SECURITY TEAM APPROACHED ME AND CALLED THE LOCAL POLICE DEPARTMENT. THE RESORT TOLD ME THAT THEY WOULD NOT PRESS CHARGES BECAUSE THERE WAS NO DAMAGE AND NO CONSUMPTION OF THE BEER. I WAS THEN TAKEN TO THE KAUAI POLICE DEPARTMENT AND LATER CHARGED BY THE COURT WITH A MISDEMEANOR SEVERAL MONTHS LATER. AT THIS TIME I AM DILIGENTLY WORKING TO GET THIS CHARGE EXPUNGED OFF OF MY RECORD AND AM WORKING WITH AN ATTORNEY TO DO SO.
