What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

 The "permitted to resign" designation on my U5 is misleading. VALIC never informed me, nor was I otherwise aware, of any pending termination related to my OBA while at VALIC. I voluntarily disclosed the OBA in question during an internal audit approximately 5 - 6 months prior to my departure. I voluntarily left VALIC to pursue another opportunity with another Broker Dealer. The proper designation for my U5 under "Termination Type" should read "voluntary". The allegation, if any are necessary, should read failure to "properly" disclose outside business activity.
