IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Complaint has been denied. Customer effected a partial exchange of an annuity that was no longer subject to surrender charges, to an annuity with superior income benefits, with the intent being to fund any short term liquidity requirements from the existing annuity, and allow the income benefit in the new annuity to increase in value by the time it was intended to be used to supplement her retirement income. It was understood and agreed that withdrawals from the new annuity would be avoided, if possible, and that, if withdrawals were necessary, withdrawals of more than 10% of the contract value would be subject to surrender charges for a period of time.
