IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement	Firm with whom Representative was previously affiliated made a settlement related to their practices leading to the complaint in order to save on legal costs - with no involvement of the Representative. Representative separated from this firm during the summer of 2022. Representative neither settled in any manner, nor contributed to any settlement related to the complaint, which was withdrawn. The one and only customer dispute the representative has had in their entire career was withdrawn with prejudice by clients - meaning the complaint cannot be brought again. Clients documented they are not opposed to the claim being expunged/removed entirely from all records. No payment or settlement of any kind was made by the representative to the client.
