What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement	IN 1986, LESS THAN A MONTH AFTER I TURNED 18 AND WAS STILL A SENIOR IN HIGH SCHOOL, I, ALONG WITH A COUPLE OF HIGH SCHOOL FRIENDS, WAS STOPPED FOR TAKING A "DIP" ROAD SIGN LEFT ON THE CURB BY A CONSTRUCTION CREW. OUR INTENT WAS TO PUT THE SIGN IN A FRIEND'S YARD AS A PRANK. AS AGREED UPON WITH THE DISTRICT ATTORNEY, I PLEADED NO CONTEST IN MARINETTE (WISCONSIN) MUNICIPAL COURT. AFTER A 90-DAY PERIOD, THE DISTRICT ATTORNEY, DISMISSED THE CHARGE AND EVEN RETURNED THE \$125.00 BOND. I STILL HAVE THE LETTER FROM THE PRESIDING JUDGE DATED AUG. 07, 1986. BECAUSE THE COURT DESTROYED THE RECORDS PERTAINING TO THIS CASE DECADES AGO, NEITHER THE MUNICIPAL COURT OF MARIENETTE NOR THE WISCONSIN CRIMINAL DEPOSITORY HAVE ANY RECORD OF THIS CASE. IN FACT, MY COPY OF THE LETTER FROM THE JUDGE AND MY OWN ADMISSION TO FINRA ARE THE ONLY DOCUMENTATION OF THIS EVENT.
