Allegations: The client states that beginning in May 2018, discussions occurred with the TIAA representative around consolidation of accounts to a single Individual Retirement Account (IRA) that allowed for investment in Exchange Traded Funds (ETF). An IRA was established and account consolidations completed in January 2019 however the IRA that was established did not allow for investment in ETFs and the client claims lost earnings as a result.

Broker Statement

The client elected to have employer plan rolled over into a IRA to gain access to simplified lineup of TIAA Core funds (familiar to employer plan) among low cost index funds, along with the ability to set automatic rebalancing for ease at \$0 management, and ultimately to simplify distributions. Client's husband, who did not have authorization on the account at the time of the transfer, may have wanted a brokerage account for ETF access but it was clear that the owner of the account was comfortable maintaining an IRA with the simplified lineup of funds and ability for automatic rebalancing. Client also committed to reviewing the investment options within the IRA as she knew the funds were to sit in cash until trades were to be placed. Funds sat in cash for 8 market days with no action nor communication taken until I reached out as a reminder that the funds were sitting in cash as a courtesy. Now client claims they wanted a specific ETF having never mentioned a symbol or trade they wanted to place on the exact day I reminded them they were in cash. Client had full access to index funds while in the IRA at relatively low cost of .3% expense ratio for over a week.
