What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations:	In a written complaint dated April 12, 2021, the customer alleged that investment advisor Randy Gay breached his fiduciary duty to her by keeping 50% of her retirement funds uninvested from June 2020, the date of inception of the relationship, through February 2021, when the customer moved her accounts away from the firm. Customer claimed \$35,000.00 in lost account growth over this period (relative to what the customer purportedly would have experienced had her account remained fully invested as it was at inception) and sought a refund of \$2,188.48 of advisory fees paid during the period.

Broker Statement	<p>Customer alleged that investment advisor Randy Gay breached his fiduciary duty to her by keeping 50% of her retirement funds uninvested from June 2020, the date of inception of the relationship, through February 2021, when the customer moved her accounts away from the firm. Customer claimed \$35,000.00 in lost account growth over this period (relative to what the customer purportedly would have experienced had her account remained fully invested as it was at inception) and sought a refund of \$2,188.48 of advisory fees paid during the period. Pinnacle Wealth Advisors investigated the claim and found no merit to the allegation of breach of fiduciary duty. The firm stands by Mr. Gay's overall management of the customer's account, and specifically, his decision to take a conservative approach to managing the client's retirement funds through the unknowns of the COVID 19 global pandemic and the 2020 U.S. Presidential Election. Without admitting any breach of duty or wrongdoing, Pinnacle Wealth Advisors settled the dispute by paying the customer a \$5,000 settlement and having the customer execute a release of all claims. This settlement is in compromise of a doubtful and disputed claim, and the payment should not be construed as an admission of liability on the part of Randy Gay or Pinnacle Wealth Advisors, whom expressly deny all liability.</p>
