**Broker Statement**

I emphatically deny the client's allegations that she did not know she was in discretionary accounts. When she transferred to me in 2017 she was in discretionary accounts at her prior firm. I explained and she signed the paperwork while we were at Wells Fargo for her to be in discretionary accounts. The accounts were rebalanced quarterly with no objections from her during that time in order to keep her in the appropriate risk tolerance. When I transferred to Raymond James, the client immediately followed me to my new firm. I explained and she signed paperwork again giving me discretion in her accounts. The accounts were again rebalanced quarterly to keep her in her appropriate risk tolerance with no objections from her. Furthermore, the client had positive returns every year she worked with me as her financial advisor. The damages she claims are from taxes paid on gains in 2019. I later learned from the client that she had also sold some bonds I was unaware she even owned, held outside of Raymond James, that contributed to her 2019 taxes.
