What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Employing firm when activities occurred which led to the complaint: Elite Wealth Management & Lattice Capital Management

Allegations: The Claimants assert multiple causes of action, including breach of fiduciary duty, negligence, negligent misrepresentation, negligent hiring, training, supervision, and retention, as well as violations of the Investment Advisers Act of 1940, Washington's Securities Act and Blue-Sky laws, Washington's Consumer Protection Act (RCW 19.86), unlawful sale of securities (RCW 21.20.140), and voidable real-property transactions (RCW 19.40). The Claimants further allege fraud, unjust enrichment, breach of contract, vicarious liability, and negligent failure to supervise. They contend that Mr. Dadgar, through his control of Elite Wealth Management Inc. and Lattice Capital Management, LLC, committed or permitted the alleged misconduct while acting as CEO and CCO.

Product Type: Other: Hedge Fund

Alleged Damages: \$103,000,000.00

Alleged Damages Amount Explanation (if amount not exact): 15 arbitrations were consolidated and collectively include over 70 claimants seeking approximately \$103 million, and if any additional arbitrations are filed it is expected that they would be consolidated.
