Allegations: The OCFI found that SIAG did not disclose the Consent Orders in Part IA Item 11 of Form ADV nor in Part 2A (Brochure), Item 9 which require that the investment adviser amend the ADV promptly in cases of changes to the information about its disciplinary history. The OCFI found that SIAG never amended its Form ADV nor the Brochure in order to disclose information about the Consent Orders. Moreover, the Brochure discloses that "SAG and its employees have not been involved in any legal or disciplinary events since the firm as founded". Thus, SIAG incurred in violation of Article 203 (c) of Act No. 60, as well as Article 25 and Section 25.6.3 and 25.6.9 of Regulation No. 6078.
