**Broker Statement** The client has made allegations against the advisor that are not supported by the facts. The advisor maintained a four-year professional relationship with the client, meeting 3-4 times annually for account reviews. During this period, the client referred her daughter for financial services, suggesting satisfaction with the advisor's work. The client received a comprehensive 50+ page financial plan with all documentation properly executed in person and digital copies provided. No concerns were raised for 2.5+ years after implementation. Client dissatisfaction



emerged only after deciding to retire earlier than professionally recommended. Ross Brenner was not named as a defendant in the subsequent arbitration. Despite documented client interactions and signed paperwork contradicting the client's claims, VALIC chose to settle the matter.
