Broker Statement

I and the firm strongly disagree with this award on my record. First, I was not a party to the arbitration-only my employer, UBS, was named as a respondent. The arbitrators did not make any finding of wrongdoing on my part, and I was not ordered to pay any damages. I also disagree that this client should have been awarded anything under the facts of this case. The client voluntarily chose to amass and maintain a large position in the stock of his employer in his self-directed brokerage account, and suffered losses when it dropped in price. The only advice I gave him was to hedge his position to protect himself from further losses. In the arbitration he sought damages for losses caused by his own trading decisions, and for profits he could have made when the stock went up had he, with the benefit of 20/20 hindsight, not correctly taken our advice to hedge and avoid the risk of further losses on the downside. I am comfortable that I and my team gave this client the same attention, respect and appropriate advice that we give all our valued clients
