What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement The arbitration claim was filed against my former employer, First Republic Bank, and settled by the FDIC. I was not named in the arbitration and did not participate in the settlement. The customer purchased First Republic Bank stock (FRC) in March 2023 prior the bank's collapse. The customer allegedly relied on a First Republic mass email sent to all clients which stated, "we are in a very strong position as you'll see below, although the stock market has tended to have a spill-over effect on our share price." I did not author the mass email, and I did not solicit or recommend the customer purchase FRC stock.
