IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement	Claimants cherry-picked investments that, unfortunately, did not perform as anticipated and sought to hold IFG and the registered representative (even though he is not named) responsible for losses suffered as a result. A review of the matter did not find evidence to support the claim that the investments were not suitable; however, in an effort to avoid the time and cost of protracted litigation, the claim has been settled. Investments were intended to provide income over a longer period of time which was in line with clients' stated investment objectives and risk tolerance. In addition, Claimants executed numerous documents that disclosed the long term and short term risks of these types of investments. Finally, the overall portfolio performed well over time which is the reason these investments were singled out. Settlement should not be deemed an admission of guilt or liability nor should it be construed adversely against either the representative or the firm.
